TREVOR DRAYTON SCHOLARSHIP JACK MYLOTT & CHELSEA RICHTER

The prestigious Trevor Drayton Scholarship was established in 2009, to provide practical and financial support to individuals demonstrating a genuine and active interest in advancing their career in the wine or hospitality industry.

The scholarship is valued at up to \$2,500 towards the purchase of resources, experiences, or further study.

Paul Tynan, representing the Trevor Drayton Scholarship Committee, praises the partnership between the Trevor Drayton Foundation and TAFE NSW, saying that it's "been a wonderful success, with many recipients forging ahead in their careers, supported by scholarship funding."

The two recipients of the Trevor Drayton Scholarship were announced at the annual Trevor Drayton Fundraiser during February 2020, and were awarded to Jack Mylott and Chelsea Richter.

As part of his Hospitality studies, Jack was fortunate enough to complete his work placement at Quay Restaurant Sydney which was his inspiration to become a pastry chef.

Jack plans on using the funds from the Trevor Drayton Scholarship to further his education through first hand experience, including travel to Europe and to attend specialised courses, then eventually, Jack hopes to re-open Mylott's Bakery, as the fourth generation baker in his family.



CAROL DUVAL MEMORIAL AWARD RUBY HART

The Carol Duval Memorial Award is generously provided by the Duval family, in memory of Carol Duval, a former fine arts teacher at TAFE NSW who embodied the true meaning of what it is to be an artist.

The award provides support and encouragement to an outstanding student who is currently enrolled in the Advanced Diploma of Visual Arts (Painting).

The 2019 recipient, Ruby Hart, was nominated by her teacher Claire Martin, and the nomination was endorsed by Head Teacher, David Trout.

"Ruby was a passionate and consistent student throughout her studies at the Newcastle Art School, completing both Diploma and Advanced Diploma of Fine Arts," Claire said. "Ruby's works tell human stories with a real authenticity and her ferocious truth allows a terrific connection to be made with a broad audience."

Ruby said she was delighted to have won and plans to put the money towards her goals of a career in art. "I wasn't expecting to win, I'm really grateful. It's so worth it, all the hard work. It feels really special and I feel really lucky to have studied at TAFE NSW and to have all the supportive teachers around me helping me out. My experience couldn't have been better."

One statement Carol Duval made about her own work was: "As an abstract painter the first concept becomes very important. I am concerned with the placement of shape and colour, allowing the work to grow. The decision to leave a shape, to modify an area of colour, clarifies the initial concept. My work is not directed at making a social comment, but a personal expression of something I have experienced. The works individually are always about something."

SONIA WALKOM MEMORIAL AWARD AND WALKOM REAL ESTATE ENCOURAGEMENT SCHOLARSHIP SARAH RALSTON

The Sonia Walkom Memorial Award began in 2015, when the Hunter TAFE Foundation partnered with Walkom Real Estate to establish the scholarship in memory of Sonia Walkom.

Sonia was a believer in continuous learning, and the award named in her honour supports a student enrolled in Certificate IV in Property Services within the Newcastle area to continue their learning. The scholarship is awarded to a nominee who shows dedication, ambition and self-discipline.

De Iuliis Wines is prominent within the Hunter region's wine industry, and Joss is an ambassador for the Hunter's wine and tourism industries.

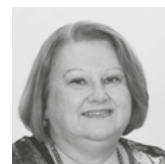


Susie George
